## INTERNET SAFETY DAY EXPANDS NATIONALLY

With increasing negative stories of teen and child involvement in activities like sexting, cyber bullying, predators, and social networking many feel there is a need for internet safety awareness. "This must start with parents and guardians taking the initiative to monitor what their kids are doing online," says Internet Safety Day organizer Brian Rice of Ohio based Family Safe Computers.

September 27<sup>th</sup> is this year's National Internet Safety Day in which parents are asked to pledge to speak with their children about online safety as well as download the free updated parent guide at [www.InternetSafetyDay.com](http://www.InternetSafetyDay.com).

This year Internet Safety Day has reached across the nation with promoters in twelve states. Events are happening across the United States helping spread the word about online safety. "We hope to see more parents and adults become involved and see the importance of monitoring what their children do online," Rice says.

According to an Internet teen survey conducted in May by the National Center for Missing & Exploited Children, 72% of 13- to 18-year olds have a personal profile on sites such as MySpace or Facebook. "The majority of teens believe posting personal information or photos on a public blog or social networking site is unsafe. However 62% of them have posted photos of themselves" and "about 2 in 5 teens say they tell their parents very little or nothing about what they do and where they go online." Unfortunately, with no parental guidance many are forced to fend for themselves online and are at high risk of becoming a statistic of Internet crime.

Internet Safety Day is an awareness day asking parents to sit down with their children at the computer and learn what they do online. Hopefully this will start a continued dialog where parents become more involved in their children's online activities.

For parents who feel a little intimidated by technology Rice suggests downloading the free updated Parent Guide at [www.InternetSafetyDay.com](http://www.InternetSafetyDay.com) for a basic crash course on what parents need to know. Also on the website, parents can join the thousands of others who have already pledged to talk with their child or teen about Internet Safety on September 27<sup>th</sup>. "Regardless of your kids technology skills it still comes down to the need for parental guidance and many times it is just common sense," Rice states.
